Tom, we are planning to put our data online this weekend, utilizing your analysis of the 2011 and 2021 redistricting for a much, I hope, simpler and straightforward coefficient of redistricting dysfunctionality, as a basis to endorse a Texas Redistricting Commission, or similar process, as a part of the Campaign. Based on your 2011 analysis which you made at the May 1, 2021 House Committee meeting on redistricting (**see attached, maybe work these notions into a preliminary narrative for the two decades, and then a chart**), and a similar analysis should be available for the 2021 district data (**I've attached a copy of the data sets that Kelly Treybig has put together**). Since the 2011 and 2021 districts will probably be different in most specific district values, they will still provide a reliable regional sense of what people around the state will face. As a further demonstration of good redistricting, I will have the testimony of the people out of Bell County asking the Committee on May 1st to please allow them to have the compact districts that they now have so that they can keep their elected officials working together for the benefit of their Bell County (and beyond) citizens.
